All information transmitted electronically from the customer (credit card) to the service Winbank Paycenter the Bank of Piraeus, and their transfer from the bank to VISA or MasterCard are covered by the encryption algorithm SSL 128-bit Veri Sign, the most powerful encryption existing today worldwide.

The tab that you insert your credit card information belongs to Winbank and the data are being collected directly by Winbank without REEVOBOOK e-Services interfering. REEVOBOOK e-Services does not collect or store and does not process in any way your credit card information and does not interfere in any way with the accomplishment of the payment. Whatever doubt or question about any charges in your credit/debit cards, users should contact the bank that has issued their card directly.

The rooms are received after 14:00 on the day of arrival and upon departure should be delivered until 11:00 (unless otherwise stated). If, due to unforeseen difficulties, REEVOBOOK e-Services is forced to change a hotel with another or a higher class, no compensation is provided. Any person booking accommodation on website www.reevobook.gr warrants that the other persons involved in the booking are authorized to do so and is guaranteed to pay it personally. Accommodation are considered validated, only if accompanied by repayment (100%) the total amount of the reservation by using a credit card or by bank deposit and after the

user has agreed to the general booking conditions of the accommodation. A voucher is issued, which the customer delivers to the property at the time of arrival. In case of non-payment of the reservation amount within 48 hours from the booking date, the reservation and voucher will be canceled without notice.

Bookings of Organized / Individual Tours & Activities

Any person booking an organized or individual trip or activity through www.reevobook.gr website warrants that the other persons involved in the booking are authorized to do so and is guaranteed to pay it personally. To be valid the reservation must be accompanied by repayment (100%) of the total value of the trip. The reservation is completed by charging the credit card of the user through the secure transaction system of Piraeus Bank or by depositing cash in a bank account and after the user agrees with the general booking conditions. All travel participants in a European Union country must have a new identity card (in Latin characters) or a new passport. For countries outside the European Union, a passport with minimum validity of 6 months from the date of travel is required. Some countries need an entry visa for which each traveler is personally responsible. Foreign residents of Greece who wish to travel abroad must consult the consular authorities of the country that will visit and obtain the necessary travel documents. REEVOBOOK e-Services accepts no responsibility in the event that the competent authorities are not allowed to make the trip due to lack or expiration or other problems that may arise with the travel documents of its customers. Cancellations of Reservations

In case you wish to make any cancellation of a reservation (hotels, organized/individual trips or activity), it must be done in writing via the website www.reevobook.gr on the "MY RESERVATION" subpage or by email at the following Email address cancel@reevobook.gr. However, REEVOBOOK e-Services is obliged to respect its obligations to its associates in organizing excursions (hotels, agents, etc.) which it is required to compensate in case of cancellations under existing agreements.

To this end, REEVOBOOK e-Services has established the following procedure in cases of cancellation for any reason, unless the customer has been notified otherwise:

1. Accommodation (Short-term leasing, Hotels, Rooms/apartments)

Before the booking is validated through the website www.reevobook.gr, the cancellation terms for the specific accommodation and dates you selected are explicitly stated by the accommodation provider. These cancellation fees prevail against the general cancellation terms listed below.

In general they apply to accommodation bookings the following cancellation terms.

- Cancellation up to 21 days prior to arrival (check in): Cancellation fee 50% of the total cost of the reservation.
- Cancellation from 20 days prior to arrival (check in) or no show at the hotel costs 100% of the reservation value.

2. Organized / Individual Tours & Activities

Before the booking is validated through the website www.reevobook.gr, the cancellation terms for the specific tour or activity and dates you selected are explicitly stated by the tour or activity provider. These cancellation fees prevail against the general cancellation terms listed below.

The customer's cancellation fees (cancellation fees) are as follows:

- Cancellation from the date of confirmation of your reservation up to 45 days before the tour/activity: 30% cancellation fee on the total cost of the reservation for organizational and communication expenses.
- Cancellation from 44 days to 35 days before the tour/activity: cancellation fee 50% on the total cost of the tour/activity.
- Cancellation from 34 days to 21 days before the tour/activity: charge of cancellation 70% on the total cost of the tour/activity.
- Cancellation from 20 days up to the day of departure: Cancellation fee 100% of the total cost of the tour/activity.

Changes / Modifications of Reservations

Before the booking is validated through the website www.reevobook.gr, the cancellation terms for the accommodation or specific tour or activity and dates you selected are explicitly stated by the accommodation/tour/activity provider. These cancellation fees prevail against the general cancellation terms listed below.

To change/modification the reservation before the start of the cancellation period, change/modification can be made free of charge. A prerequisite is that there is availability on the new date and there is no difference in price. If there is a difference in price, the customer is informed in advance and if he agrees it is required to pay the difference.

Changes/Modifications of reservation after the start of the cancellation period are considered cancellation of the existing booking with the applicable charges and a new booking will be started.

In special cases of holidays or special events, accommodation/tours/activity providers are likely to apply stricter cancellation terms. In any case, the customer is informed of the exact cancellation/change terms before finalizing the booking and must accept them before proceeding with a reservation.
